Fees are due and payable at the time the permit is issued. No fees are required from organizations that qualify as charitable under Section 501 of the IRS Code.

For a businesses obtaining a Special Event there is a limit of 12 permits to any location in a year with a minimum of 1 day and a maximum of 3 consecutive days per event. Each permit issued shall represent a single event of 1 to 3 days and the fee shall be calculated per day, per event. A permit must also be obtained from the State Office of Alcohol & Tobacco Control for each Special Event. For information you may call 925-4041.
